What is the YMCA electronic transfer plan?

Terms and Conditions

1. I understand that this is a continuous dance or gymnastics payment plan and will remain in effect until the end of the program year or as indicated in the "Draft Schedule" below.

2. I understand that if I wish to terminate the draft for dance or gymnastics fees, I must give the YMCA a 30-day written notice and complete a cancellation form. I understand that my account may be drafted during this 30-day period.
