# Application for Electronic Fund Transfer September 2022 - August, 2023

## What is the YMCA electronic transfer plan?

The program provides a way to budget your YMCA swim team fees on a monthly basis. With your authorization, swim team fees are deducted monthly from an account of your choosing.

#### What are the benefits of such a program?

*Convenience.* You save time and mailing costs. With our automatic electronic transfer, there are no checks to write, no stopping at the customer service desk every month.

*No additional fees.* There is no extra charge for using the YMCA's electronic fund transfer payment plan.

Any adult, 18 years of age and older, who has an account (checking or credit) at a participating financial institution.

#### How do I sign up?

By completing this authorization form and returning it along with a voided check (if applicable) or copy of credit card. The check must be preprinted with a customer's name on it. We will then complete our verification process.

This is in addition to any service fee my bank may make. I understand that it is my responsibility to notify the YMCA in writing should I change my financial institution and or account at any time.
